### Applicant Eligibility List - Second Application Window

This Applicant Eligibility List reflects eligible applications received within the second application window (October 8, 2024 - November 22, 2024). Applicants within each tier (Tiers 1-3) were ranked based on the timestamp of submission\* of their completed Application Part A. Additional information on applicant prioritization can be found on page 8 of [CARB's ZESBI Implementation Manual](#).

Funding has been reserved for applicants that have progressed to Application Part B, however, placement on the Applicant Priority List does not indicate a funding award. All applicants will need to submit additional documentation as described in [CARB's ZESBI Implementation Manual](#) and [CEC's ZESBI Implementation Manual](#).

During the second application window, the amount of requested funding exceeded the amount of available funding. As a result, a waitlist has been permitted. Waitlisted applicants are not guaranteed funding, nor is there a guarantee funding will become available. Funding availability is based on demand, and any cancellations during the funding process. Should funds become available, the highest priority tier applicants from the waitlist will be selected, based on the timestamp of their completed Application Part A submittal, to receive incentive funding.

The ZESBI infrastructure award allows for a maximum of one ZESBI-funded charger for each ZESBI-funded zero-emission school bus. The number of chargers per applicant is not reflected below, as applicants do not finalize charger quantity until Application Part C.

If an applicant submitted more than one application during the second application window, their name may appear multiple times below.
